The Nonprofit Difference

Capital Caring Health is proud to be a 501(c)(3) nonprofit organization, serving our community for nearly 50 years. Studies have shown significant variations in both the cost and quality of care provided by nonprofit and for-profit hospices. Much of the discrepancy comes down to how and where each organization directs its resources.

The National Partnership for Hospice Innovation (NPHI) commissioned a survey comparing the care of Medicare patients by nonprofit and for-profit hospices. The ensuing 2019 report compiled by Milliman, the global actuarial and consulting firm that conducted the study, revealed the following findings.

Compared to for-profit hospices, nonprofit hospices provided patients with:



The 2019 Milliman report findings are consistent with other studies on the Medicare hospice benefit, including those by the Department of Health and Human Services Office of Inspector General, Government Accountability Office, and the Medicare Payment Advisory Commission. All reports identified significant differences in the quality of care and use of Medicare funds between nonprofit and for-profit hospices.

Exploring Innovations in Dementia Treatment and End of Life Care

with *Diane Ty*

Diane Ty is the Senior Director of the Milken Institute Center for the Future of Aging and also leads its Alliance to Improve Dementia Care. She is a Senior Advisor at Georgetown University's Business for Impact at the McDonough School of Business, where she previously led multiple consulting engagements in health and financial security and was the Founding Director for its AgingWell Hub and Portion Balance Coalition.

Ms. Ty previously served as Senior Vice President of Strategic Market Development at AARP, where she architected the organization's under-50 / Millennial strategy. Ms. Ty led Save the Children's Millennial-focused work as Managing Director of US Programs and orchestrated the Effie-winner and Emmy-nominated Ad Council campaign "Do Good: Mentor A Child."

Diane Ty's passion for improving quality of life for individuals facing dementia also extends to her work on Capital Caring Health's Board of Directors. We are honored to speak with her about this important topic.



What challenges and opportunities do you see today and going forward – especially with the aging of the Baby Boomer population and the expected increase in dementia in the next five years from 10 million to 14 million Americans?

One of the biggest challenges with dementia is that most people do not know the difference between normal aging and when there may be cause for concern. This, coupled with the fact that our healthcare system does not routinely screen for cognitive impairment, results in inaccurate, late-, and under-diagnosis and contributes to misconceptions and stigma related to dementia. We see a huge opportunity to focus on prevention – regular exercise, nutritious eating, quality sleep, and managing hypertension and type 2 diabetes, for example – all lifestyle factors that reduce one's risk for dementia and promote better heart and metabolic health. With disease-modifying therapies now available to treat mild cognitive impairment and early-stage Alzheimer's disease (AD), we see an opportunity to normalize routine brain health screening, especially for populations at increased risk for dementia. We also now have blood tests and scans that can detect the hallmarks of the disease well before symptoms develop.

Many Americans are unaware that late-stage dementia is a hospice-qualifying event. Are there ways that the public can be better informed about palliative and hospice care?

Late-stage Alzheimer's disease and related dementia is often the shortest stage among individuals with dementia, lasting from one to two years on average. Palliative and hospice care are ideal for people at the most advanced stage when cognitive and functional status have typically declined to the point where assistance is needed for all activities of daily living (like bathing or dressing), incontinence is experienced, swallowing is difficult, and mobility is limited. These symptoms may result in more frequent doctor or emergency room visits and are qualifying symptoms for hospice care.

We need all people engaged in care – paid and unpaid caregivers, practitioners, community health workers and promotores – to be trained about the benefits of hospice and palliative care, for whom, and when it is most appropriate. My dad and our entire family greatly benefited from hospice care during his last six months living with AD and from palliative care during his final days.

There are several new drugs that seem to slow Alzheimer's disease progress but also may have serious side effects. Do you have hope that drug research will ultimately effectively combat Alzheimer's disease and related dementias?

2023 has been an exciting year for innovation in the dementia care field, but it's only the beginning; I am optimistic about where treatment is heading. In addition to the recent FDA full approval of Leqembi®, there are more than 180 trials assessing 141 drugs for the treatment of AD in the pipeline, including drugs already approved but being evaluated for re-purposing. And, given the complexity of the disease, we see a future where there will be combination therapies and precision medicine based on an individual's unique pathology. In the meantime, people living with dementia can benefit from comprehensive dementia care that includes caregiver training and a care navigator to help bridge medical and social care services and provide continuous monitoring of care.

At Capital Caring Health, we provide robotic companion pets to dementia patients, which often improve their daily lives and those caring for them until the last few weeks of living with the disease. Do you see other ways for non-conventional therapies to be used?

I love Capital Caring Health's commitment to providing robotic pets to dementia patients! Music and other art forms are beneficial for brain development and overall brain health. Repeated listening to music benefits brain plasticity – the ability of its neural networks to change through growth and reorganization – and can profoundly affect memory, reasoning, speech, and emotion. According to the Alzheimer's Association, studies have demonstrated that listening to music may reduce agitation and improve behavioral issues that are common in the middle stages of AD. Even in the late stages of the disease, a person may be able to tap to a beat or sing lyrics. Music can provide a way to connect, even after verbal communication has become difficult.

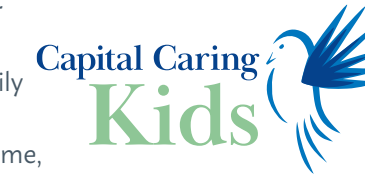

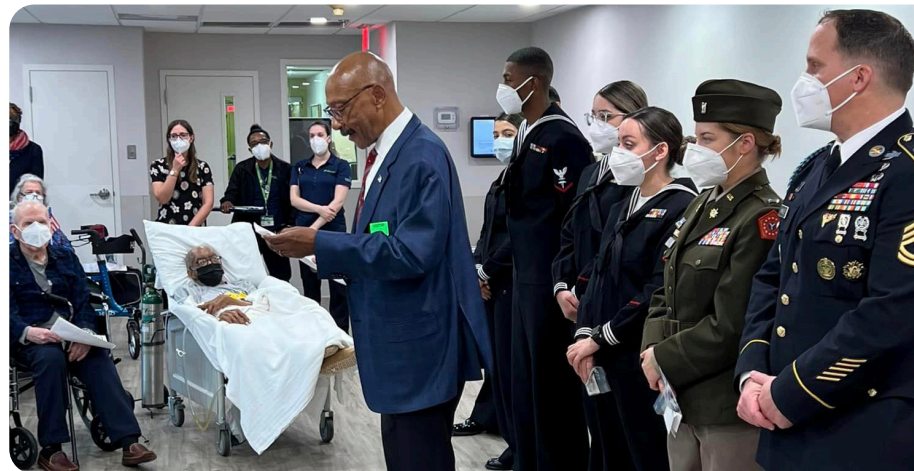

Center for Health Equity

Capital Caring Health ensures that everyone, regardless of race, ethnicity, gender, sexual orientation, citizenship, or socio-economic status has access to advanced illness care of the highest quality.

In 2022, the Center for Health Equity engaged with 20,000 patients, families, caregivers, and community partners to address hesitancy and barriers to accessing advanced illness care in underserved communities. The Center partnered with faith-based organizations to share information and resources, training, outreach, and grief counseling support to communities of color throughout DC, Maryland, and Virginia.

Point of Hope Camp

Our camp theme this year was **Journey Together** and grief support activities centered around the beautiful fable of how water bugs transform into dragonflies. This tale provides a meaningful metaphor for helping young hearts and minds to understand death and loss.

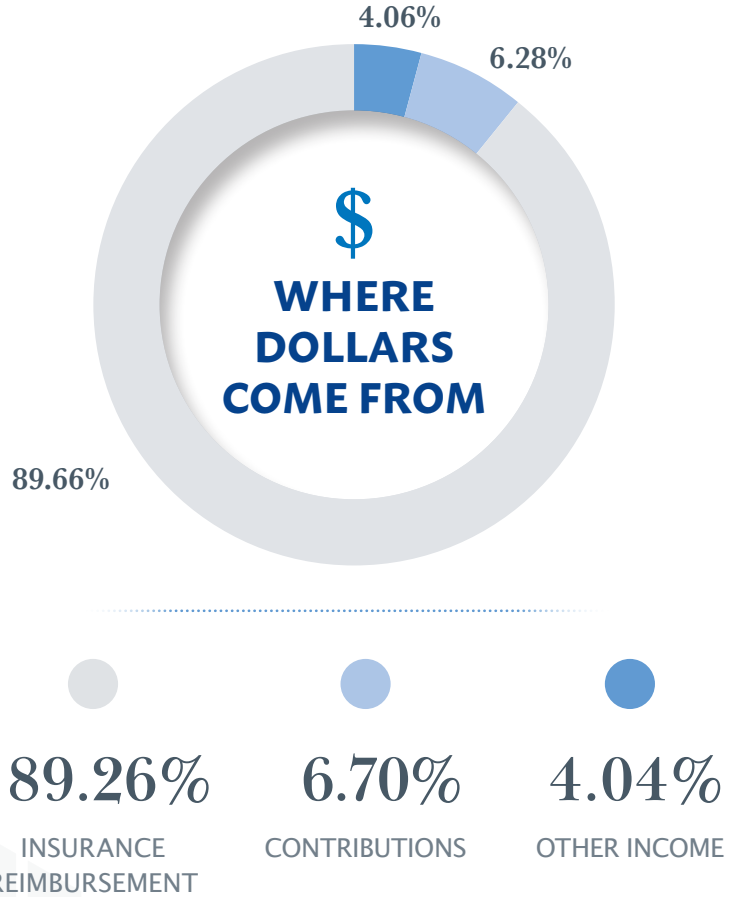
