Today, many of the 5.7 million Americans with advanced heart disease are living longer and better lives. However, even some of the best medical therapies eventually fail—and more invasive interventions are often contraindicated or rejected by the patient and family as too severe.

Healthcare providers are then confronted with a difficult dilemma—how best to manage patients with end-stage heart disease in the face of limited, if any, options. Hospice is often the answer.

Hospice for Heart Disease: The Facts

More than 1 million congestive heart failure (CHF) patients are admitted to inpatient settings each year, often for breathing difficulties or fatigue. Yet many of those admissions could have been prevented through palliative and hospice care.

With its focus on symptom and pain management, supportive and spiritual care, hospice can improve the quality of life of patients suffering from end-stage CHF. Care is typically provided in the patient's own home, which also contributes to a sense of well-being and comfort.

Intriguingly, for patients with CHF, hospice may actually extend life. According to one study, CHF patients who chose hospice had a mean survival of 402 days versus 321 for those who did not.¹

Studies also show that the majority of caregivers and families would have welcomed information about hospice at the time they learned of their loved one's terminal diagnosis.²

Hospice Referral Guidelines

For patients with CHF and other advanced coronary disease (chronic ischemic heart disease, left-sided heart failure, previous myocardial infarction), physicians should consider hospice in the presence of any of the following clinical indications:

- Identification of specific structural/ functional impairments
- Ejection fraction <20% (not required, but an important consideration)
- A poor response to diuretics and vasodilators
- Dyspnea or tightness in the chest
- Impaired heart rhythms, contraction force of ventricular muscles and impaired blood supply to the heart
- Changes in appetite, unintentional weight loss
- Impaired sleep functions
- Decline in general physical endurance
- Relevant activity limitations and or impaired mobility
- NYHA Class IV functional status

Only a physician is able to determine whether a CHF patient meets the qualifications to be admitted to hospice. However, the above signs and symptoms in patients with CHF or other end-stage cardiac conditions strongly suggest that the current approach to care is no longer working.
